

This month, the Village of Cass City published a 4" x 7" Public Notice for the proposed Ordinances # 202, 203 and 204. The Cass City Chronicle would have charged \$80-90 for the single print publication. The Tuscola Advertiser is charging \$405 for a similar publication. There are no other newspapers in Tuscola County for the Village of Cass City to publish, even though the prices have sky-rocketed.

The State of Michigan has offered an option for smaller communities to publish their notices on a municipality's official website, in lieu of a newspaper.

Public Act 182 of 2009, in the Michigan Compiled Laws, allows for an official website to fulfill the requirements of publishing public notices when the following conditions are met:

- Municipal population is less than 12,000 people
- · Municipality has an official designated website
- Website is updated regularly
- · Website has a clearly designated link for Public Notices
- A Notification Process has been completed and documented:
 - Municipality has published a notice in a newspaper for 3 consecutive weeks announcing its intent to publish public notices on its website
 - Notice must include the website address
- For residents without internet access, a paper copy of notices must be available upon request

Some notices are required by law to be published in a newspaper. These notices will be published on the website AND newspaper when required.

- 7. Optional Nature: This act provides an option, not a requirement. Local governments that meet the criteria can choose whether to use this alternative method or continue with traditional newspaper publication.

It's worth noting that while this act provides flexibility, some specific types of notices may still require newspaper publication under other laws. Local governments should carefully review all applicable statutes before changing their notice procedures.

A Professional Services Agreement is required by the USDA for our Wastewater Treatment Plant Project and potential bond.

Fishbeck agrees to perform engineering services necessary as outlined in the Agreement Between Owner and Engineer for Professional Services. The full agreement has previously been provided via e-mail to the Village Council. The full agreement will be included in the scanned council packet for the August 28, 2023, meeting posted to our website. A copy of the agreement is available for viewing at the Municipal Building also.

The Village Attorney has reviewed the document. The contract terms are standard and do not contain any unfair or illegal provisions. They have no recommended revisions or additions. The Attorney has approved the contract in its form and advises the Village to approve the scope of work and price.

The responsibilities of Fishbeck and the Village are outlined in the Professional Services Agreement Exhibits and Appendices. There are five (5) phases of engineering work. Fishbeck will provide:

Preliminary Design at a cost of \$280,000
Final Design and Permitting at a cost of \$610,000
Bidding/Negotiating Phase at a cost of \$20,000
Construction Phase Engineering at a cost of \$460,000
Post-Construction Phase Engineering at a cost of \$30,000
Resident Project Representative at a cost of \$250,000

The total compensation for Fishbeck's services is estimated to be \$1,650,000. The Village will be applying our \$238,000 ARPA allocation to pay for some of these fees. The Village petitioned Tuscola County for \$250,000 of the County ARPA allocation to fund the WWTP engineering costs. The remainder of the fees will be paid from USDA funds.

Staff requested an update to our policies and contracts to include prohibiting e-cigarettes and vaping in Village buildings and facilities and in vehicles or other motorized equipment. At the Personnel and Public Safey Committee held on June 14, they discussed adopting an E-Cigarette/Vaping Administrative Policy. The Committee recommended staff prepare a policy for the Village Council to review and consider.

Administrative Policy

Prohibiting E-Cigarette/Vaping

To protect indoor air quality and to protect the health, safety, and comfort of employees, customers, and visitors of the Village of Cass City. E-cigarettes pose health risks and contain detectable levels of carcinogens and toxic chemicals. These chemicals are also present in secondhand emissions. E-cigarettes are not a safe alternative to smoking, and there is no scientific evidence that they help smokers quit.

Definition:

Vaping refers to the use of electronic nicotine delivery systems or electronic smoking devices.

Policy:

This e-cigarette policy prohibits the use of electronic nicotine delivery systems (also known as e-cigarettes, e-cigars, e-hookahs, and e-pipes) anywhere that tobacco smoking is prohibited.

No vaping is permitted within the facilities of the Village of Cass City at any time. This includes, but is not limited to, common work areas, conference and meeting rooms, private offices, employee lounges, restrooms, employer-owned or leased vehicles and other motorized equipment, and all other enclosed facilities.

This policy is effective immediately.

Procedure:

Staff, visitors, and clients will be informed of the Village of Cass City's e-cigarette-free policy through signs posted throughout properties owned and operated by the Village of Cass City.

Any visitor observed using e-cigarettes on owned or leased premises will be asked to discontinue use in a tactful manner.

Any employee violations of this policy will be handled through the standard disciplinary procedure.

Day-to-day operations have kept me busy this month of August with permits, events, personnel matters, and customer service to our residents. I have been working with the Police Department concerning their vacant SRO position, and a separate update will be forthcoming after the job notice expires at the end of next week. This month I received notification from Teamsters Local #214 who represent DPW and Parks employees that they are ready to negotiate a new contract that would start in 2025. I have been notified by an adjacent property owner that one of our lift station generators is on his property. As more information becomes available, I will keep you informed. Also, at the request of an adjacent property owner, I have been working on vacating a platted street that is undeveloped. This matter has been referred to the Village Attorney and will appear on a future village council agenda.

FORESTRY COMMITTEE

We have a committee of volunteers who will meet for the first time on Wednesday, August 28 at 5:30 pm at the Municipal Building. We will be reviewing information provided by the DNR concerning best practices for municipal trees in the downtown and right-of-way areas in neighborhoods. We will discuss applying for grant funds for this project. We do have funds budgeted for the replacement of trees this year (\$15,000). I am seeking feedback on the timing as I anticipate the installation of Christmas decorations which are placed on our trees. This committee will also assist with the preparation of a Forestry Ordinance for the Village. I am grateful for the community volunteers and look forward to adding to the tree population and canopy in the Village and improving the trees and streetscape in the downtown area.

SEPTEMBER COMMITTEE OF THE WHOLE

The September 11, 2024, Committee of the Whole meeting was tentatively scheduled to discuss the Village's strategic planning goals in advance of the budget preparation. I am

unable to attend this meeting and respectfully request that the Village Council consider rescheduling. This matter has been placed on your agenda for discussion.

BUDGET PREPARATION FOR 2025

Staff have already started working on the budget for 2025. In anticipation and preparation of the need for data, we have scheduled a meeting with our MESSA Representative for August 28, to receive the proposed healthcare rates for employees. On September 24, we have scheduled a meeting with Mike Engels of Michigan Rural Water Association to work with staff to prepare the utility rates for our budget. The Village will need to hold their strategic planning session to determine if the budget should include funding to support our strategic planning goals and objectives.

SEPTEMBER

September is right around the corner. Village staff perform annual employee evaluations in the month of September. September is also my anniversary date, and the Personnel and Public Safety Committee have discussed the Village Manager's annual evaluation to be performed and the use of a new form. In addition, my 3-year employment contract expires this year.

In other matters, I will be out of the office the second week in September and have appointed Police Chief Jim Freeman as Acting Village Manager during my absence. I have sent an email to the Council, Department Heads, and staff concerning this matter. Thank you, Chief Freeman, for agreeing to take on this additional responsibility.

WASTEWATER TREATMENT PLANT

The Wastewater Treatment Plant Staff continue to work on items scheduled from the Preventative Maintenance Program.

- We have completed our monthly Selenium, and the data has been sent to the state.
- Quarterly test of Whole Effluent Toxicity and annual metals testing completed

- We have drained and inspected final clarifiers. Also, cleaned out all pressure relief valves in the finals.
- Lab continuing water testing.
- Working with engineers on plant design.

There were no violations of our NPDES permit for the month of July.


