E-Cigarette/Vaping

Administrative Policy

Purpose:

To protect indoor air quality and to protect the health, safety, and comfort of employees, customers, and visitors of the Village of Cass City. E-cigarettes pose health risks and contain detectable levels of carcinogens and toxic chemicals. These chemicals are also present in secondhand emissions. E-cigarettes are not a safe alternative to smoking, and there is no scientific evidence that they help smokers quit.

Definition:

Vaping refers to the use of electronic nicotine delivery systems or electronic smoking devices.

Policy:

This e-cigarette policy prohibits the use of electronic nicotine delivery systems (also known as e-cigarettes, e-cigars, e-hookahs, and e-pipes) anywhere that tobacco smoking is prohibited.

No vaping is permitted within the facilities of the Village of Cass City at any time. This includes, but is not limited to, common work areas, conference and meeting rooms, private offices, employee lounges, restrooms, employer-owned or leased vehicles and other motorized equipment, and all other enclosed facilities.

This policy is effective immediately.

Procedure:

Staff, visitors, and clients will be informed of the Village of Cass City's e-cigarette-free policy through signs posted throughout properties owned and operated by the Village of Cass City.

Any visitor observed using e-cigarettes on owned or leased premises will be asked to discontinue use in a tactful manner.

Any employee violations of this policy will be handled through the standard disciplinary procedure.

A Committee of the Whole Meeting of the Cass City Village Council was held Thursday, September 26, 2024 at 6:00 p.m. at the Municipal Building.

Staff Present were Debbie Powell, Village Manager, Nanette Walsh, Clerk/Treasurer, Jim Freeman, Police Chief, Melanie Radabaugh, Community Development Director, Parks and Recreation and RJ Klaus, Utilities Director

Police Department:

Police Chief Jim Freeman gave an overview of the 2024 Police Overtime levels that were higher than originally anticipated due to the union contract mandating that any open shifts be filled by full-time officers first, then the Police Sargeant, then part-time personnel. Full time officers claimed these time slots, driving overtime costs exponentially. As a result, management looked for options to manage the budget, potentially re-opening the union contract, seeking an agreement to re-negotiate coverage terms for open shifts, or management rights to cut hours of service, eliminating overtime. Roundtable discussion resulted in the option to seek an agreement to re-negotiate coverage terms for open shifts.

MESSA Health Insurance:

Manager Powell gave an overview of the Proposed 2025 MESSA Health Insurance Rates, with an initial 17.5% rate increase. By changing the prescription coverage from a 3-Tier to a 5-Tier coverage level, the rates dropped to a 10% increase. Management recommended offering two plans to employees, the higher deductible plan would be offered with no employee contribution to the premium costs, while those who wished to have a lower deductible plan would pay the difference in premium costs, using a pre-tax payroll deduction.

Utility Rates:

Mike Engels, from Michigan Rural Water Association, was in Cass City this week to prepare a Water and Sewer rate study for 2025. His draft report was presented by Manager Powell, with emphasis on proposed 2025 Water Operational Rates, 2025 Sewer Operational Rates, and 2025 Sewer Debt Repayment Rates.

Marketing Update:

Kim Rivera, New Moon Visions, will be present at the next Committee of the Whole Meeting on Monday, October 7, 2024 to present draft Logos and Taglines for branding options for the Village of Cass City. Comments and input are welcome.

Listing Expiration for Industrial Park Properties:

The six month agreement for listings for selling the Industrial Park Properties expires October 4, 2024. After discussion, the consensus was to extend the agreement for an additional six months.

There were no Citizen's Comments.

Other Business, a brief overview of a meeting with Aspire/Hills and Dales Hospital regarding zoning non-compliance with residential properties recently acquired by the hospital to convert to office space. The intention of the acquisition is to have office space located near the hospital to meet expectations for Medicare maximum funding. A request for rezoning these parcels was submitted by hospital officials.

By consensus, the meeting was adjourned at 7:30 pm.

SUBJECT: Approve zero turn mower purchases for Parks Department

The Parks & Recreation committee is recommending the purchase of (2) new zero-turn mowers for the Parks Department. Over the past several years, two of our three current units have cost the Village several thousands of dollars in repairs, often leaving the staff short on mowers. The 2014 Kubota F3990 now needs a new engine, which exceeds the value of the unit, and the 2009 John Deere 1600 Turbo just had repairs of over \$3,800.

New mowers were planned purchases for 2025; however, due to the breakdown of equipment it is recommended to purchase these units for the Parks Department in 2024.

The Parks & Recreation committee explored quotes on 8 different models of zero turn mowers, from Bad Boy, Country Clipper, John Deere, Kubota, Exmark, Gravely, Ferris and Cub Cadet, from 6 area dealers including Tri-County Equipment, Farm Depot, Morrell Equipment, TNT Equipment, Ball Equipment, and Kirk's Landscaping. It was the committee's recommendation NOT to purchase another Kubota or John Deere, due to the amount of service issues we've had with those manufacturers. Our staff was able to DEMO the use of the Bad Boy, Hustler, Country Clipper and Exmark brands, and based upon feedback on quality, ride/comfort, warranty, serviceability and price, have made the following recommendation.

Ball Equipment has offered to take the 2009 John Deere 1600 Turbo as a trade-in on (2) Exmark Lazer Z, X-Series, 72", gas, zero-turn mowers at a price of \$14,399 each. The trade-in value on the John Deere is \$8,000, which our staff feels is appropriate for its year/condition. These new mowers would be available to the Village in 7-10 days once ordered.

MOTION #1: Approve budget amendment to use the Motor Vehicle Fund Balance, increasing Account# 651-000-699, Transfer from Fund Balance, in the amount of \$21,936, and increasing the Motor Vehicle Capital Outlay line item, 651-001-970, in the amount of \$21,936.

MOTION #2: Approve the purchase of (2) Exmark LZX921, 72" zero-turn mowers from Ball Equipment in the amount of \$20,936, which includes the trade-in value of \$8,000 for the 2009 John Deere 1600 Turbo. Funds are available in the Motor Vehicle Capital Outlay Fund, #651-001-970.

Taxes:

At this writing, 93% of the Village Taxes have been paid, with the balance of unpaid taxes transferred to the Tuscola County Treasurer at settlement, prior to October 1, 2024. Every year, the Village of Cass City has a goal of 90% paid taxes, to meet requirements for the Annual Michigan Department of Treasury Municipal Qualifying Statement, which shows the Village is in good standing for Bonding/Borrowing as a municipality. This is extremely important this year, as we bond for the Wastewater Treatment Upgrades Project.

Uncapping Taxable Values

This tax season, we had a number of new taxpayers ask for an explanation why their tax bill was so much higher than the previous year. In each scenario, the new home owner just purchased their home, which was previously owned by someone who had owned that home for many, many years, even decades. With the Headlee Amendment, the Assessed Value of the property rises in value according to the market, but the Taxable Value is limited by the Inflation rate of each year, which deflates the taxable value, significantly.

After a lengthy amount of time, the gap was significant between the Assessed Value and the Taxable Value. When the property was sold to the new owner, the value was "uncapped" and the Taxable Value rose to equal the Assessed Value. That jump in taxable value brought about the increase in taxes.

After this explanation, the new home owners understood the process of "uncapping" the taxable values upon the purchase of their new home, but were disappointed at the surprise of higher than prior year tax amounts. If any future homeowner has concerns on their prospective future property tax amounts, we welcome these questions.

2024 Michigan Municipal Treasurer's Conference

This week, I attended this annual conference with 273 fellow Treasurers, Bankers, and Finance Officers in sessions on Artificial Intelligence, How to Keep Residents in their Homes via Probate Court, Economic Updates, How to Work with and for Elected Officials, Fraud Case Studies, The Importance of Region Banks, Breaking down Banking, What Matters and Are Banks the Same, Practical Ways to Combat Cyber Threats and Leadership Lessons from Normandy/D-Day.

Economic Update: Investments

With the recent interest rate cut by the Federal Reserve, the interest rates of the last year are now decreasing, and are expected to fall for about two years, before leveling off. The Village of Cass City investments will be reviewed in its entirety this week, to best position itself to



withstand the down slope of rates. There appears to be a short window to maximize our investment position.

Indicators show the economic growth is increasing, though not as strong in Michigan. Economies differ in different regions. Though food, heating and transportation costs are up, these personal consumption factors are not included in the Core Consumer Price Index (CPI) and Personal Consumption Expenditures (PCE) Index. So when we hear that the Inflation Rate is decreasing, but our consumption costs seem to be increasing, and it doesn't seem to make sense, it's because those consumption costs are stripped out of the formula. (See Attached Graphs)

Fortunately, the politics surrounding the upcoming election were not factored into the Economic forecasts. The proposed economic plans are not current policy, and economic direction would begin upon the election outcomes.

Working with Your Council

A great round table discussion explored the relationship between Treasurers (Municipal Staff) and the Village Council and best practices:

- Clearly understand the community goals
- · Build community relationships
- Craft messages with the Council to the Public
- · Speak positively on behalf of the Council
- Provide research and data
- Build networks together
- Build positive culture
- Define purpose
- · Culture keeps changing, address new needs and expectations
- · New members on boards, keep up with training, re-training
- Lastly, remember, "I'm here to make you successful!"

The Importance of Region Banks, Breaking down Banking, What Matters and Are Banks the Same A presentation on utilizing local banks to finance infrastructure in local communities, in a manner currently seen in Japan was presented, but questioned by attending Treasurers, who cited PA-20, which limits local borrowing (as Installment Purchase Agreements) to a maximum 15-year repayment term. Most repayments terms on infrastructure projects are 30 - 40 years. A panel of small – medium depository bankers explained their banking services, with a philosophy that most any service is negotiable, and to always network with your local bank representatives.

Practical Ways to Combat Cyber Threats

Scary, but so informative. Municipalities are hit twice as often as other industries. Change passwords often. Usernames and passwords are stolen frequently. Change the passwords, and change the "formula" of the passwords to stay a step ahead.



Best prevention is to lock the "entry door" of your computer. Most breaches start with a bad email. If it looks odd, don't open it. Pay attention to the details, timing, names and titles. We now have third party authentication tools; it's going to be four party authentications very soon. Use a passkey if available, they can't be intercepted.

This was a legitimate government agency to assist with Cyber Security, and was highly recommended.










Fed's Preferred Inflation Progresses






2-Year Treasury Reflects Changing Expectations



The following is a summary report for the activities that took place at the Wastewater Treatment Plant and Department of Public Works for the past month.

WASTEWATER TREATMENT PLANT

The Wastewater Treatment Plant Staff continue to work on items scheduled from the Preventative Maintenance Program.

Additional items that were completed:

- All three lift stations have been checked for routine maintenance.
- We have completed our monthly Selenium, and the data has been sent to the state.
- Quarterly test of Whole Effluent Toxicity and annual metals testing completed
- The crew has continued to do general/routine maintenance around the plant.
- We have drained and inspected final clarifiers. Also, cleaned out all pressure relief valves in the finals.
- Lab continuing water testing.
- Working with engineers on plant design.

There were no violations of our NPDES permit for the month of August.

The average flows treated were:

360,000 gals/day for August 2024

307,000 gals/day for August 2023

TMF Grant

Village staff applied for a Grant and has been awarded through MIEGLE Community Technical, Managerial, and Financial support for lead service line replacement. This grant is a 100% federal grant with no match required, to perform more verifications of our water service lines

Project Overview

This project involves work related to the development of Village of Cass City's (Cass City) lead service line replacement (LSLR) program. Field verification will be conducted for approximately 50 service lines at properties where lead is suspected but not confirmed or where service line material is unknown but likely contains lead, based on Cass City's knowledge of service line materials at the time of this agreement. This includes effort by

Cass City staff to pothole on either side of each curb stop and perform in-building investigation to document service line materials. Some locations may also be potholed at the corporation stop to determine the presence of goosenecks, which are short sections of material used for connection between the corporation stop and the service line piping. This project includes applicable restoration to original condition of potholed locations. Cass City will also pursue public education and outreach efforts related to lead service line verification and/or replacement program implementation. This effort includes website updates, the development of community outreach materials, and holding public information sessions

Police Activity Report for September 2024

Ashley Coleman has been hired as the new full-time Patrolman/SRO. Ashley comes to us from the Tuscola County Sheriff's Office with ten (10) years of experience. Ashley was an outstanding candidate and will be an invaluable asset to the Village.

Due to traffic concerns, I have requested MDOT to conduct a traffic study at the intersection of Main Street and Doerr Road. There is no fee associated with this study and it will determine whether a traffic light, 4-way stop, or no change is warranted.

The 2025 Ford Police Interceptor Utility vehicle arrived last week. We are currently in the process of setting it up for patrol.


